### PRIVATE AGREEMENT

#### for a Fixed-Term Transfer of an Amateur Football Player (Male / Female) (article 6 of Annex B of HFF's RSTP)

**a)** Mr./Ms. ...., acting in the capacity of President or as the legal representative of the club ....., which competes in the ..... Division, hereinafter referred to as the "**releasing club**",

**b)** Mr./Ms. ...., acting in the capacity of President or as the legal representative of the club ....., which competes in the ..... Division, hereinafter referred to as the "**receiving club**", and

have mutually agreed and explicitly accepted the following terms and conditions:

#### Terms of the Agreement

An agreement was reached between the first and second contracting clubs regarding the transfer of the third contracting party, the football player, through the issuance of a fixed-term Player's Registration Card, subject to the obligation for the player to return to the releasing club upon expiry of the transfer duration, (article 6 of Annex B of HFF's RSTP), under the terms set forth in this Agreement.

After the expiration of the above agreed duration, the player, automatically and without any further action, returns to the force of the 1<sup>st</sup> (releasing) club .....

The three contracting parties have the right to legally extend the validity of this Agreement, not exceeding one (1) sports season, or to mutually terminate the Agreement earlier, but always exclusively within the predetermined transfer periods.

Any amendment herein, permissible only during the one transfer season, will be encompassed by the written form.

This and any subsequent written amendment shall be activated and become legally effective as soon as it is submitted to the Hellenic Football Federation, through the relevant Regional Amateur Football Association, in conjunction with the submission of the rest supporting documents for the player's transfer.

Any agreement containing any financial consideration, either compensation for the clubs or remuneration for the player, is strictly prohibited.

Any dispute between the parties shall be resolved by the competent bodies of the Hellenic Football Federation (Players' Status Committee).
