### PRIVATE AGREEMENT

**between an amateur club and a foreign football player [male / female]  
(article 1§2 of Annex B, or article 9§4 of Annex C of HFF's RSTP)**

In ....., today on ..... the day of the week being .....,

**A.** On the one hand, the amateur club under the legal name ".....", with its headquarters in ....., VAT number ....., hereinafter **"the club"**, legally represented herein by ....., in his status as .....of the amateur club, and

**B.** On the other hand, ..... son of *[Father's name]* ..... and *[Mother's Name]* ....., resident of ....., hereinafter **"the player"**, agreed, stipulated and jointly accepted the following:

#### Scope of application

##### Case A:

In implementation of the exception foreseen in article 1 par. 2 of Annex B of HFF's RSTP, permitting the signing of a private agreement between a club and an amateur player, with the payment of a specific amount of money monthly by the club to the player, not in the form of remuneration for the provision of his/her services, but only to cover the costs of accommodation, food, travel and insurance and in order the special purpose residence permit in accordance with the provisions of Law. No. 5038/2023 to be issued, the sports club under the legal name ".....", declares that intends to include the player ..... in its force and the other party consents and accepts, with the following terms and conditions:

### **Case B:**

Pursuant to Article 9 par. 4 of Annex C of the HFF's RSTP, this PRIVATE AGREEMENT shall be used obligatory for any type of transfer concerning refugee football players who are under asylum seeker or international protection status.

Based on the abovementioned, the sports club under the legal name ".....", declares that intends to include the player ..... in its force and the other party consents and accepts, with the following terms and conditions:

### **TERMS AND CONDITIONS OF THE PRIVATE AGREEMENT:**

#### **Duration of validity**

The duration of this Agreement is set at ..... (...) year/years, starting from ..... to .....

It is noted that **according to Article 1§2 of Annex B of the H.F.F.'s RSTP, it is mandatory that the start, as well as the end date of each Private Agreement to fully coincide with the start and end date of the Player's Registration Card, as indicated in the respective document (Application for Player Registration Modifications) submitted through the relevant Regional Amateur Football Association to the Hellenic Football Federation for the issuance of the Player's Registration Card.**

#### **Obligations of the amateur club**

The club is obliged to provide the player with all the necessary conditions (access to sports facilities, training material, clothing, etc.) so as to ensure the best possible preparation for him / her and participation in training sessions and matches. In addition, the club undertakes to complete the registration/transfer procedure of the player, covering the corresponding costs, as well as any other financial obligation arising from the present and not expressly stipulated.

The club is obliged to pay to the player, on the last day of each month, the amount of ..... (.....,00) euros, which is the amount agreed to cover the above accommodation, food, travel and insurance costs. The aforementioned monthly amount shall not, under any circumstances, constitute a disguised employment contract or a remuneration for the provision of services by the player.

It is expressly stated that the above amount relates to the player's own costs and not to the club's activities. Therefore, in the event that the club's squad travels to an away venue, the costs of accommodation, food and travel are covered exclusively by the club, in addition to the above monthly amount paid to the player.

### **Obligations of the Player**

The player is duty-bound to participate in all competitive activities of the club (matches, training sessions, etc.), complying with the orders and instructions of the technical staff of the club and showing respect to teammates, coaches, members of the club's administration and fans of the club. If there is a written, internal Regulation of the club, the player shall accept it.

This agreement shall be terminated automatically at the foreseen contractual expiry or by mutual agreement, at any time, which shall be concluded in the legally required written form, and there may be a continuation of cooperation between the club and the foreign player, if both parties wish that, in the manner provided for in paragraph 3 of article 1 of Annex B of the HFF's RSTP.

In case of culpable violation of the terms of this Agreement by any of the parties, the provisions of the H.F.F.'s RSTP apply (in particular, the provisions of articles 1 par. 5 of Annex B, 21 par. 5 and 25 par. 9 of the H.F.F.'s RSTP).

Any amendment to this Agreement agreed at a later date shall be in writing.

The present document, as well as any subsequent written amendment shall become effective and legally enforceable upon submission to and validation by the Hellenic Football Federation, provided that the Player's Registration Card has been issued (for the issuance of which this document is intended).

For any dispute arising from the implementation of the present, competent to adjudicate are: a) the First Instance Committee for the Resolution of Financial Disputes and b) the Players' Status Committee of the Hellenic Football Federation, depending on their respective responsibilities.
